With QuickBooks Enterprise, you can also quickly and easily create a business plan to help you secure a loan, or plan for the future.

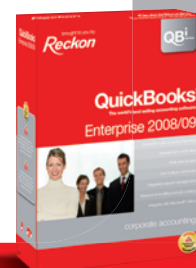

Straight forward tracking of tax and GST

QuickBooks now contains an intuitive and more accurate tax tracking system for day-to-day transactions and for tax and BAS reporting.

Tax Items are now linked to Tax Codes so you can't accidentally assign the wrong sales or purchase tax code.

Payroll enhancements

- A new **Payroll Setup Wizard** helps first-time users set up integrated payroll with clear and concise instructions at every step.
- All employee records and payroll transactions are now centralised and available at your fingertips in the **Payroll Centre**. Plus you can now customise your employee list to suit your requirements.

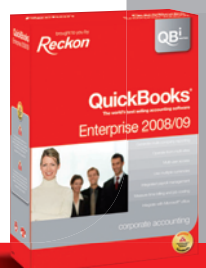
